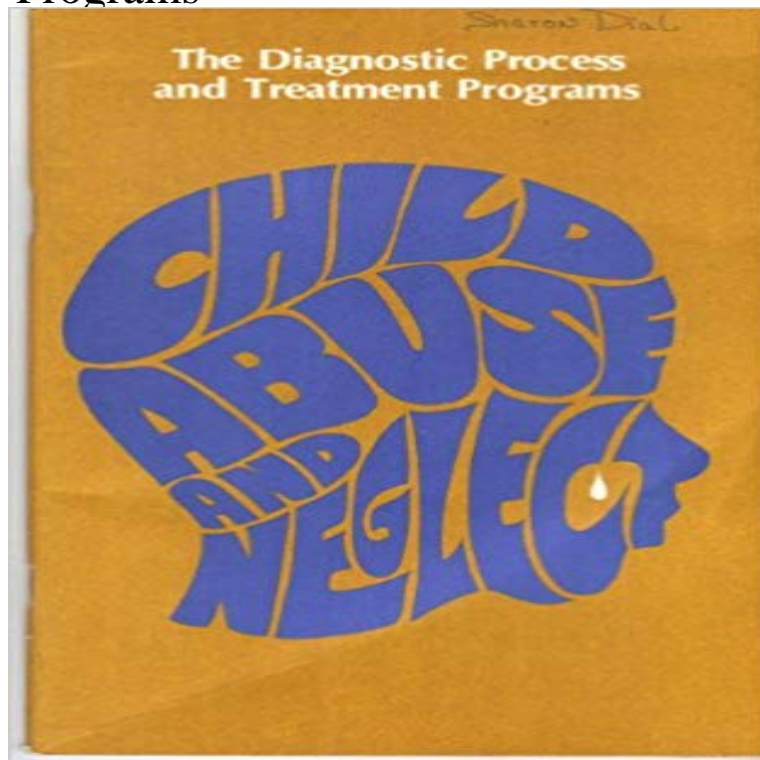


Child Abuse and Neglect: The Diagnostic Process and Treatment Programs



On January 31, 1974, the child abuse prevention and treatment act was signed into law. The act established for the first time within the Federal Government a National Center on Child Abuse and Neglect. Responsibility for the activities of the Center was assigned to which, in turn, place the center within the Childrens Bureau of the Office of Child Development. The Center will provide national leadership by conducting studies on abuse and neglect, awarding demonstration and research grants to seek new ways of identifying, diagnosing and preventing this nationwide problem, and by giving grants to States to enable them to increase and improve their child protective services.
