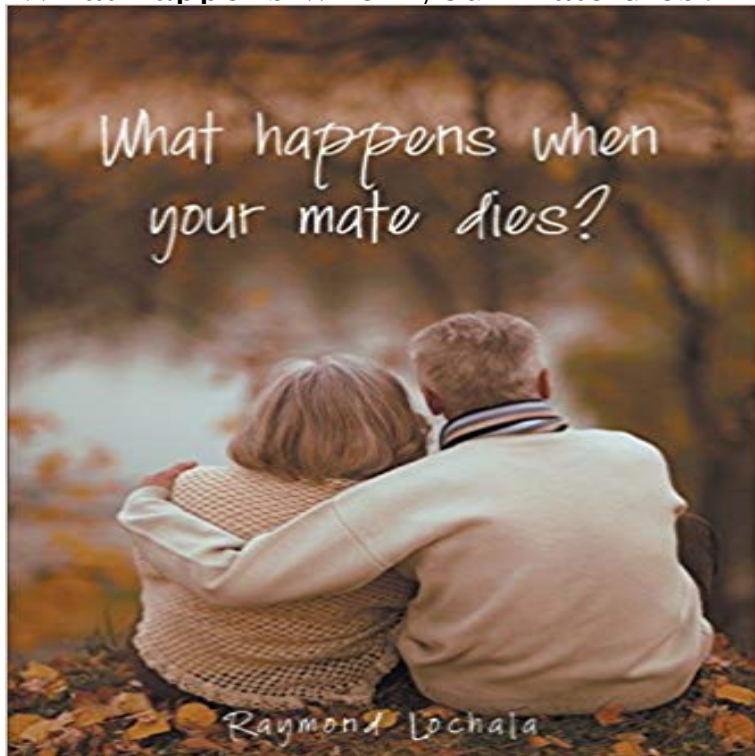


## What happens when your mate dies?
